### CONSTRUCTION NOTICE: QUINTANA ROAD AND LA LOMA AVENUE

July 23, 2021

Construction is scheduled to begin on **Monday, Aug. 2** at Quintana Road and La Loma Avenue as part of the City of Morro Bay Water Reclamation Facility (WRF) Pipelines. The WRF Program is the largest-ever City infrastructure program, and will meet state water and wastewater regulations, protect the environment and contribute a safe and reliable water source for Morro Bay's residents and businesses.

**What To Expect:** Construction will be completed on Quintana Road from La Loma Avenue to Morro Bay Boulevard within the public right-of-way. The eastbound lane on Quintana Road will be open, and the westbound lane will be closed to traffic except for access to business driveways. **Residences and businesses requiring access via Quintana Road between La Loma Avenue and Morro Bay Boulevard should access the area from Morro Bay Boulevard (i.e. the Roundabout).**

The project team will work to minimize inconveniences associated with traffic, construction noise and large construction equipment, and access will be maintained for business, residential and emergency vehicle access. Driveways to businesses will remain open. Please follow all posted signage near the work zone.

The WRF Pipelines include two wastewater pipelines, one pipeline for the water treatment process discharge, and one purified water pipeline. The construction will include trenching, pipe installation, soil backfilling and offhauling, and road restoration. In addition to this area, construction is also ongoing on Quintana Road between Kennedy Way and Morro Bay Boulevard.

**When:** Construction is scheduled on weekdays from 7 a.m. to 5:30 p.m., and work on Quintana Road and La Loma Avenue is scheduled to begin on **Monday, Aug. 2**. Weekend or night work may be scheduled, as needed, but neighboring properties will be informed in advance of schedule changes.

**Why:** The City of Morro Bay is investing in the construction of the WRF Program that will protect our environment, and provide a safe, clean and reliable water supply for our community, both current and future generations. The WRF Program involves replacing the City's existing wastewater treatment plant with an advanced water purification facility that will create a drought buffer and will be capable of providing up to 80 percent of the City's water needs in the future.

The City is committed to providing up-to-date information about construction activities. Properties along the construction area will receive printed notices before work begins near their address, and construction notices will be regularly posted on [morrobaywrf.com](http://morrobaywrf.com).
